Colour Scheme Professionals Inc. will warranty for 48 months against peeling, chipping or blistering paint or stain, which is the result of poor or improper workmanship. We will return the following spring, for 2 years, to inspect your project for defects and repair per our warranty.

### The customer must perform the following for the above captioned warranty to be effective:

 Provide a copy of the original executed Proposal Agreement. Contact Colour Scheme Professionals Inc. in writing within the warranty period and as soon as the defect is known.

### Colour Scheme Professionals Inc. will perform the following:

- Repair failed areas only. Prepare the surface same as stated in the Proposal Agreement and touch-up paint same as stated in Proposal Agreement.
- Repair failed areas at no labour cost to the customer. Paint colour and sheen will not be an exact match in some areas of touch-up due to possible fading.
- 3. Customer to provide materials for touch-up.



#### The following is not covered by this warranty:

- Painting and carpentry where the customer supplies material.
- Failed areas due to water damage, moisture damage, ground contact damage & due to excessive moisture content with in the substrate, greater than 12%.
- 3. Lap marks, fading, chalking, bleed through from knots, rust stains, tannin bleed.
- 4. Horizontal or sloped painted or stained surfaces includes decks and fences.
- 5. Chipped paint due to abuse or "wear and tear". Any damage to stucco or masonry coating, which may occur due to ongoing, concealed deterioration. This may manifest as efflorescence, a white chalky leaching of salts to the surface, accompanied by a crumbling of the stucco or masonry surface.
- Acts of God. Not responsible for damage from Downspouts Removed in order to carry out work.
- 7. Rotted wood or previously partially rotted wood, or rotted wood due to paint failure.
- 8. Coating failure resulting from previous coat breakdown. Some coatings will release from the surface of the substrate after the application of new paint. The new coating dries and "pulls" the aged coating from the substrate. Identifying this in advance is not possible. This phenomenon is most likely on wood siding. Recoating of affected areas and remediation will be charged on a time and material basis.
